- 1) The Vehicle must be in road worthy Condition, shall not be more than three years old from the date of initial registration and must have valid registration Certificate. Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of Vehicle.
- 2) The Driver of the Vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experience in driving transport passenger Vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) The monthly rate of hired charges be quoted separately In the General bid information (excluding fuel and lubricants) as per finance dept. notification.
- 5) The vehicle must have achieved a fuel efficiency of **17kms** per litre for Desire/Etios.
