 - The bidders must have PAN Card
 - Bidders must submit the last three years ITR file or Authorized Chartered Accountant certificate.
 - Delivery, Installation & Commissioning of the service within 4 Weeks receiving of Work Order.
 - Warranty shall be covering 2 years from the date of Delivery.
- The bid shall be submitted as per the specification stated in **Annexure-A**, else bid shall be rejected.

2. **Validity:** - The bid should be validity for periods of 60 days from the date of publish of bid.
 3. **Project Period:** The successfully bidder will be supplied and commissioned the entire equipment within one month and warranty & maintenance period shall be 2 Years after Supply of the equipments.
 4. **Warranty & Maintenance:** The warranty & maintenance support shall be start from the date of Final Acceptance Test (FAT). The selected bidder shall be responsible to provide warranty & on-site maintenance support for all supplied items for a period of 2 Years.
 5. **Training:** The selected bidder shall be responsible for providing end user training at Office of the Utkalika.
 6. **Bid Processing Fees:-** The bidders must have submitted an amount of Rs.500/- (Five Hundred Only) which is non- refundable in shape of Demand Draft in favour of **"Odisha State Co-operative Handicrafts Corporation Ltd."**, payable at Bhubaneswar.

The Performance Guarantee shall be kept valid till completion of the project and support period.

 10. **Payment:** - The payment shall be made with the following terms.
 - Payment shall be made:
 - 80% after Supply of the products and accessories.
 - 20% after successful demonstrate of the system & necessary.
 - Operation & Maintenance Support shall be paid equally in Quarterly for two year from Final UAT.
