Odisha State Co-operative Handicrafts Corporation Ltd. (Utkalika), Odisha, established in 1959, is an apex Cooperative Society functioning under the administrative control of the Handlooms, Textiles and Handicrafts Department, Government of Odisha. The Corporation has been actively engaged in providing marketing support to the artisans and weavers of the State, thereby promoting and preserving the rich cultural heritage of Odisha.

Utkalika facilitates the sale and promotion of handicraft and handloom products through its wide network of emporiums and sales outlets. At present, the Corporation operates 11 outlets within the State and 6 outlets outside Odisha. In addition, it has expanded its outreach through digital platforms by promoting Odisha handicrafts through its official online portal, www.utkalikaodisha.com

B. OBJECTIVES

In order to broaden market outreach and provide enhanced access to marketing platforms for a larger number of artisans and weavers, Odisha State Co-operative Handicrafts Corporation Ltd. (Utkalika), Odisha proposes to engage eligible and experienced agencies/artisans for the display and sale of their handicraft and handloom products through its various outlets.

- i. The Agency shall submit the EoI in a sealed envelope clearly indicating the name and address of the Agency. The EoI, along with all supporting documents, shall be submitted in English. The envelope should be superscribed as “**Expression of Interest (EoI) for Selection of Agency for Sale and Display of Handicrafts and Handloom Products.**”. It should contain the forms (Schedule A, B, C, D& E) and any other relevant documents, duly signed by authorized representative of Agency with Seal.
 - ii. EoI documents complete in all respects must be submitted to **The Managing Director, Odisha State Co-operative Handicrafts Corporation Ltd (Utkalika), D2/3 & 4, Industrial Estate, Rasulgarh, Bhubaneswar-10** through courier / speed post / hand-delivery only so that they are delivered to the address on or before the time and date mentioned in the Data Sheet. Any EoI received after the stipulated deadline shall be returned unopened. EoIs submitted through Fax/E-mail shall not be entertained.
3. **Selection process:** -The EoIs received shall be opened and scrutinized by a duly constituted Committee. The Committee shall evaluate the proposals based on the offered sales target and other relevant criteria. The Agency offering the highest (H1) sales target and meeting the eligibility requirements shall be selected. A detailed engagement order shall thereafter be issued to the selected Agency.
 4. **Signing of Agreement:** -The selected Agency shall enter into an Agreement with Odisha State Co-operative Handicrafts Corporation Ltd. (Utkalika), Odisha on mutually agreed terms and conditions.
 5. **Schedule of Payment :** - Payment to the engaged Agency shall be made on a monthly basis, preferably by the 15th day of the succeeding month, towards the display and sale of handicrafts and handloom products, subject to submission of necessary documents.
 6. All disputes shall be subject to the jurisdiction of courts at Bhubaneswar, Odisha.
 7. **The Managing Director, Odisha State Cooperative Handicrafts Corporation Ltd, Utkalika** reserves the right to reject any or all offers without assigning any reason thereof.

Terms and conditions for Special Consignment business (all crafts) at All outlets of Utkalika

After selection, the concerned consignor will abide by the rules & regulations for consignment business in Utkalika outlet in and outside the state with commercial principle for display & sale their product.

1. The period of consignment business will be for a period of 24 months, can be extendable by maximum upto 3 months subject to satisfactory performance.
2. All the products will be sold through Corporation bill and the Corporation will impose service charge on the net sale price (i.e. Gross price minus discount offered to the customers).
3. The selected Party shall allow 10% discount on Handicrafts & 20% on Handlooms on the price mentioned for the product to all the Customers indiscriminately borne by the party.
4. During the annual rebate spell period, the party will give 10% rebate on Handicrafts item and extra 10% on Handloom products.
5. Service charges will be 15% on net sales for metal crafts and 20% for all others.
6. Beyond the approved annual rebate period, if the party feels to gives extra discount, it will be borne by the party. (Example: Gross sales Rs.100 - Rebate Rs. 10 = Net Rs. 90.)
7. The party shall maintain stock records and a daily sales register at the counter. All activities shall be regulated through Utkalika's ERP system. The party must submit stock details to the branch manager periodically. Stock entry shall be done by the party as per branch manager instructions.
8. Payment against bill/ sale proceeds will be made to the party after submission of bills.
9. The party shall engage their own excellent-quality sales staff for product sales and display. Staff must adhere to showroom operating timings (like Utkalika's own staff), exhibit professional and courteous behaviour, possess strong communication skills, product knowledge, neat appearance, punctuality, and a customer-focused attitude, and be trained in retail basics. Identity details of all salespersons must be submitted to the branch manager beforehand.
10. The party will ensure quality of stock and obey rules and regulations of Corporation and maintain stock levels at a minimum of 60% of the sales target. Utkalika reserves the right to verify stock periodically; any discrepancies must be rectified by the party immediately.
11. The party must provide silver filigree items, accompanied by purity certificates of BIS and hallmarks, but purity of any items should not be less than 80%.
12. Insurance coverage/ transportation/ loading & unloading charges of the stock to be made by the party and copy of insurance policy must be submitted to the Branch head.
13. The party shall deposit 10% of the net sales target as security before agreement/work order. Any shortfall in service charges if found to be recovered from sales proceeds.

14. Branding of Utkalika is mandatory in each and every product. If the Agencies/artisans keeping products in their own brand name is noticed at any point of time, the party will be disengaged immediately and security to be forfeited.
15. That the Second Party shall not engage in the trade or sale of similar items within the same market complex/area where the emporium of the First Party is situated, either personally or through his/her representatives. In case any such activity is detected, the First Party shall have the right to terminate the agreement forthwith without issuing any further notice.
16. Proper packaging of all the items in an attractive way must be done by the agencies/artisans.
17. Authority possesses every right to cancel the EOI process, if required.
18. Any dispute(s) arises between the parties shall be settled with mutual understanding and if not settled, the same shall be settled within the jurisdiction of the court(s) of Bhubaneswar only.
